Terms & Conditions

1. Registration

Registrations will be recorded by date of receipt and confirmed in writing with a binding effect.

2. Terms of payment

When registering, 50% of the participation fee is to be paid as deposit. The rest of the participation fee (50%) will be invoiced in November. After completion of the event, exhibitors will receive a final invoice of individually incurred costs not covered by the standard package. All invoices are due in 21 days of the invoice date, unless agreed otherwise.

3. Cancellation

In case of cancellation up to 3 months prior to the physical beginning of the event 50% of the participation fee is to be paid. In case of cancellation later than 3 months prior to the physical beginning of the event, 100% of the participation fee is to be paid.

4. Stand allocation

It is not possible to choose a place allocation within the stand. We reserve the right to place any exhibitor in the most suitable location and to make slight adjustments if necessary. The exhibitors will be informed about location of the stands.

5. Obligations of Deutsch-Norwegische Handelskammer Services AS

DNHKS is committed to arrange the event as described in the registration form, provided a sufficient number of participants. In the case of an insufficient number of participants or significant changes in external preconditions, DNHKS can dissolve the event. In this case, information will be given to participants in good time. Paid registration fees will be refunded.

6. Force majeure

DNHKS is not accountable if the implementation of the project fails due to circumstances that are beyond the control of DNHKS, such as: strikes, natural disasters, lockout, changes in legislation, or similar. If, due to the above mentioned conditions, the project may not be performed, the registered participants are liable for the costs incurred, including project management.

7. Disagreements

If disagreements arise connected to this project, the legal department of DNHKS will try to resolve the dispute. Should this not lead to success, the parties will authorize the Oslo City Court for a judicial resolution of the dispute.
